We take your privacy very seriously. In this privacy notice, we seek to explain to you in the clearest way possible what information we collect, how we use it and what rights you have in relation to it. We hope you take some time to read through it carefully, as it is important. If there are any terms in this privacy notice that you do not agree with, please discontinue use of our Services immediately.

This privacy notice applies to all information collected through our Services (which, as described above, includes our App), as well as, any related services, sales, marketing or events. 1. WHAT INFORMATION DO WE COLLECT? Information collected through our App

In Short: We collect information regarding your geo-location, when you use our App.

If you use our App, we also collect the following information:

Geo-Location Information. We may request access or permission to and track location-based information from your mobile device while you are using our App, to provide certain location-based services. If you wish to change our access or permissions, you may do so in your device's settings.

This information is primarily needed to deliver the global positioning service inside our App, in particular it will be used to provide you your position when you are saving a meditation session.

2. HOW DO WE USE YOUR INFORMATION?

In Short: We process your information locally to provide you the geolocalization service, in compliance with your consent.

We use personal information collected via our App for the purposes described below.

We use the information we collect or receive:

• To deliver and facilitate delivery of services to the user: We may use your information to provide you with the requested service.

3. WILL YOUR INFORMATION BE SHARED WITH ANYONE?

In Short: We do not share any personal, user-related information with any third party. Data is local to your device and won't be accessible by us.

We do not have access to your data and personal info as it is collected and processed locally only into your device.

We, however, give you the ability to connect to the following platforms, with the following modalities:

- Facebook App: You may be able to share your meditation sessions onto the sharing platform. Note that we do not share any content with it but under your previous login into the Facebook platform and your explicit consent.
- Dropbox App: You may be able to backup your meditation sessions onto the Dropbox platform. Note that we do not upload/download any content from/on it but under your previous login into the Dropbox platform and your explicit consent.

Note that these platforms are not operated by us, hence we have no responsibility for the content, privacy policies, or practices of any third-party sites or services. Make reference to their Privacy Policy to have more info.

4. IS YOUR INFORMATION TRANSFERRED INTERNATIONALLY?

In Short: We do not transfer, store, and process your information in any country.

Our Application is not connected to any server. Data won't be transfer from/to any country.

5. HOW LONG DO WE KEEP YOUR INFORMATION?

In Short: We do not store your data anywhere but on your device.

Your information will be stored locally. We do not have any control on it. Any user related information will be stored into your device till you uninstall the application.

6. CHILDREN'S PRIVACY

In short: We do not collect information from children under 13 years old.

As we do not collect any personal information the Application does not collect personal info of children under 13 years old. However, we do not consider us responsible for the installation and use of our services since those remain a parent's responsibility.

7. WHAT ARE YOUR PRIVACY RIGHTS?

In Short: You may review, change, or terminate the application at any time.

If you are a resident in the European Economic Area and you believe we are unlawfully processing your personal information, you also have the right to complain to your local data protection supervisory authority. 8. CONTROLS FOR DO-NOT-TRACK FEATURES
